The city also agreed to the installation of a water line to the property if Mr. Hoft builds a home on the location within a five-year period and the city would grant a perpetual easement to the property providing the engineer's approval. The city would offer \$3,500 down with the balance to be paid on April 1, 2009. Roll call was taken and vote was as follows:
